ORDER : The Court made the following order :-

The petitioner, who was arrested on 21.03.2024 for the offence under Section 379 IPC r/w 21(1) of Mines and Minerals (Development and Regulation) Act, 1957 in

2.The case of the prosecution is that the petitioner has illegally transported four bags of river sand in a two wheeler bearing Registration No.TN 50 R 0711.

3.The learned counsel appearing for the petitioner submits that the petitioner is the sole accused in this case. For the statistical purpose only, the present case has been falsely foisted as against this petitioner.

4.The learned Additional Public Prosecutor appearing for the respondent strongly opposes for grant of bail and submits that the petitioner is having 29 previous cases pending as against him and one case is similar in nature. He has also produced the list of cases before this Court.

5.In view of the above submission made by the learned Additional Public Prosecutor that the petitioner is having 29 previous cases pending as against him, this Court is not inclined to grant bail to the petitioner.

6.Accordingly, this Criminal Original Petition is dismissed.
