ORDER

The present Criminal Revision Case has been filed seeking orders to set aside the judgment in C.A.No.19 of 2019 dated 03.02.2021 passed by the learned Additional District and Sessions Judge, Dindigul, confirming the conviction and sentence imposed by the learned District Munsif cum Judicial Magistrate, Natham in C.C.No.84 of 2013 vide judgment dated 03.01.2019 and consequently, acquit the petitioner from the aforesaid case.

2. It is seen from the records that this revision was taken at National Lok Adalat and the parties have entered into a compromise and on that basis, a Lok Adalat award came to be passed on 14.12.2024.

3. In view of the settlement between the parties and consequent passing of the award, the judgment of conviction passed by the Courts below are hereby set aside and the accused is acquitted from the charges.
