6.The Petitioner as a document writer has been permitted to prepare the documents since he possess a qualification for preparing the documents. Not all persons are permitted to prepare the documents. The petitioner knowing the procedure for preparing the documents has violated the same by creating a false documents. The petitioner as a licensed document writer cannot plead innocence by stating that he would mechanically prepare the documents which has been produced by the parties.

7. Though the petitioner has raised several grounds, this Court is of the opinion that it can be appreciated only during the trial. Therefore, these Criminal Original Petitions are dismissed.
