Prayer : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, to direct the 3rd respondent to restore the drainage channel to its original status for flow of drainage water flowing in the passage of 4 feet width and 50 feet length in between the 4th respondent compound wall and the house of Mr.Gandhi in Door No.8/2-158-1 after removing the blockage of steel gate installed in the frontage of the passage and the cement mortar plaster coverage made over the existing

drain channel put up by the 4th respondent blocking the flow of drainage water of 2nd street of Kamaraj Nagar of 3rd respondent Town Panchayat in pursuance of his notice Na.Ka.No.06/2024 dated 28.03.2024 and considering the petitioner's representation dated 19.03.2024 within the period that may be stipulated by this Court.
