Prayer in WP(MD). 27383/ 2023 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the Respondent Nos. 1 and 2 to Extend the ordinary leave to the petitioners husband from 23.11.2023 to 13.12.2023 for further 20 days by considering petitioners representation dated on 10.11.2023.
