2.The case of the prosecution is that the defacto complainant is running a business, dealing with silver articles. On 08.03.2024, when he returned from Pudukottai with 7 kgs of silver in a two wheeler along with his friend, the accused persons have thrown chilly powder on the petitioner and robbed the silver.

3.The learned counsel for the petitioner submits that the petitioner is an innocent and his name is not found in the First Information Report.
