3. The learned counsel appearing for the petitioner submits that the petitioner did not involve in any crime as alleged by the prosecution and petitioner was falsely implicated in this case.

4. The learned Additional Public Prosecutor appearing for the respondent strongly opposes for grant of anticipatory bail to the petitioner that he has involved in nine cases of similar in nature.

5. Considering the nature of offence and the antecedents of this petitioner, this Court is not inclined to grant anticipatory bail to the petitioner.

6. Accordingly, this criminal original petition is dismissed.
