It is seen from the records that this Court, vide judgment dated 30.01.2024, directed the learned I Additional District Judge, Tirunelveli, to dispose of the suit in O.S.No.15 of 2009 within a period of two months from the date of receipt of copy of that order. Subsequently, on the requisition submitted by the learned I Additional District Judge, Tirunelveli, this Court vide order, dated 05.06.2024 granted two months further time. Now, the learned I Additional District Judge, Tirunelveli, has submitted a requisition, dated 23.07.2025, stating that there are 53 items of properties in the final decree application; that the Commissioner is yet to file his report and seeks two months further time to dispose of the case.
