3.The learned Government Advocate (Crl. side) appearing for the respondent Police submits that petitioner has posted defamatory statements in social media against the inter-caste marriage. Also, he submitted that the offence is against the society. Therefore opposes for grant of anticipatory bail to the petitioner.

4.Considering the nature of offence and also considering the submission made by the learned Government Advocate (Crl. side), this Court is not inclined to grant any relief to the petitioner. Accordingly, this Criminal Original Petition is dismissed.
