Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a WRIT OF CERTIORARIFIED MANDAMUS, calling for the records pertaining to the impugned order of the 1st Respondent Lr. No.CE/Comml./EE3/AEE3/F.Thanjavur EDC/D.85/12, dated 14-03-2012 and quash the same and direct the Respondents to re-pay a sum of Rs.1,41,542/- with interest from the date of payment till the date of realization.
