2.When the matter was taken up for hearing earlier, this Court directed the respondent Police not to permit the dismissed employees to conduct the shop pending disposal of these writ petition.

3.The learned counsel appearing for the private respondent would submit that subsequent to the order of this Court, they have closed the shop and as of now no one is running the shop.

4.The learned Additional Public Prosecutor appearing for the official respondents would submit that on the basis of the complaint given by the petitioner, an enquiry has been initiated in CSR.No.11 of 2024 and after enquiry, the same was ordered to be closed.

5.The learned counsel appearing for the petitioner would submit that since the entire articles were kept in the shop, they may be permitted to open the shop and take them, for which, the learned counsel appearing for the private respondents raised serious objection.
