The first respondent, as the writ petitioner, has filed the writ petition seeking for issuance of a Writ of Mandamus directing the fourth respondent herein/Tahsildar to permit the petitioner to celebrate the temple festival of Arulmighu Sri Palamalaiyandi Swamy, Sri Thottichiyamman, Sri Karuppasamy at Palamalaiyanpatty, Senthurai village, Natham Taluk, Dindigul District on 16.01.2019, based on his representation dated 10.12.2018. The Writ Court, by order dated 21.01.2019, disposed of the said writ petition, by granting the permission to conduct the festival. As against which, the fifth respondent in the writ petition has filed the present writ appeal.
