2. The grievance of the petitioner is that though this case was registered in the year 2022 and final report was filed in the month of January 2023, the trial has not been proceeded.

3. The learned Additional Public Prosecutor submits that the accused Nos. 4 and 5 in C.C.No.1149 of 2023 have filed an application seeking quashment before this Court in CrI.O.P.(MD)No. 6095 of 2023 and initially, this Court has granted an order of interim
