3.The learned counsel appearing for the petitioner submits that he never committed any offence as alleged by the prosecution. He is the sole bread winner of his family.

4.The learned Additional Public Prosecutor appearing for the respondent strongly objects for grant of bail to the petitioner due to the installation of the electric fencing, the defacto complainant's father died.

5.Considering this conduct of this petitioner, this Court is not inclined to grant bail to the petitioner. Accordingly, this Criminal Original Petition is dismissed.
