connection with a case in Crime No.46 of 2024 for the offence under Sections 147, 148, 294(b), 324, 307 and 506(ii) of IPC has filed this petition seeking anticipatory bail.

2.The learned counsel appearing for the petitioner submits that the petitioner is an innocent person and he has not committed any offence as alleged by the prosecution. Hence, he prays for grant of anticipatory bail to the petitioner.

3.The learned Government Advocate (Crl. side) for the respondent Police submits that due to civil dispute between the petitioner and the defacto complainant, the petitioner and the other accused have attacked the defacto complainant's brother and also threatened the defacto complainant. The injured has been admitted in the hospital as inpatient in an emergency ward from 04.04.2024.

4. Considering the nature of injury, this Court is not inclined to grant any relief to the petitioner. Accordingly, this Criminal Original Petition is dismissed.
