ORDER

2. If the respondent Police is not taking any action on the petitioner's complaint dated 23.02.2024, he is having an alternative remedy either before the concerned Superintendent of Police under Section 154(3) Cr.P.C. or before the concerned Judicial Magistrate Court under Section 156(3) Cr.P.C.
