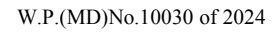

2. Heard Mrs.K.Porkodi, learned counsel appearing for the petitioner and Mr.K.S.Selvaganesan, learned Additional Government Pleader appearing for the respondents.

3. By consent of both the parties, this writ petition is taken up for final disposal at the admission stage itself.

4. The petitioner, who was working as a Co-operative Sub-Registrar/Field Officer at Kamuthi, was suspended from service on the basis of a charge framed against him alleging that he had failed to properly verify the list of beneficiaries for Co-operative Loan Waiver Scheme.

5. Mrs.K.Porkodi, learned counsel appearing for the petitioner would submit that an enquiry officer was appointed in the domestic enquiry and detailed report has been filed by the enquiry officer on 12.05.2021, stating that the charge framed against the petitioner was not

In view of the said reason, there shall be a direction to the third respondent to consider the representation of the petitioner dated 14.02.2024 and pass orders to revoke the order of suspension, on merits and in accordance with law, within a period of two weeks from the date of receipt of a copy of this order.
