ORDER : The Court made the following order :-

The petitioner, apprehending arrest at the hands of the respondent Police, in connection with a case in Crime No.103 of 2024, for the offence punishable under Section 4(1)(a) and 4(1-A) of Tamil Nadu Prohibition Act, has filed this petition seeking anticipatory bail.

2. The case of the prosecution is that the petitioner was found in possession of 21 Nos of arrack bottles, without any permit. Hence, the case.

3. The learned counsel appearing for the petitioner submits that the petitioner is an innocent person and he has not committed any offence as alleged by the prosecution. Hence, he prays for grant of anticipatory bail to the petitioner.

4. The learned Government Advocate (Crl.Side) appearing for the respondent Police submits that one previous case is pending against the petitioner.

5. Considering the facts and circumstances of the case and the nature of offence committed by the petitioner, this Court is inclined to grant anticipatory bail to the petitioner.
