This Petition is filed to extend the time as directed by this Court in Crl.O.P. (MD)No.3918 of 2024 vide order dated 12.03.2024, to surrender the petitioners before the learned District and Sessions Judge (PCR Act Cases), Special Court for Exclusive trial of cases under SC/ST (POA) Act, Sivagangai, in Crime No.61 of 2024 on the file of the second respondent police.
