As and when any document is presented for registration, the registering authority would definitely act as per law. I cannot presume or anticipate that the registering authority will act illegally.

3.Leaving open the contentions of the petitioner, this writ petition is dismissed. There shall be no order as to costs. Consequently, connected miscellaneous petitions are closed.
