ORDER : The Court made the following order :-

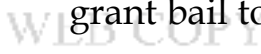
The petitioner / Sole Accused, who was arrested and remanded to judicial custody on 01.05.2024 for the offences under sections 4(1-A), 4(1)(d) of Tamil Nadu Prohibition Act in Crime No.286 of 2024 on the file of the respondent Police seeks bail.

2. The case of the prosecution is that the petitioner has illegally prepared 9 ½ litre Toddy from Date Palm Tree for the purpose of selling the same to the public. Hence the complaint.

3. The learned counsel for the petitioner would submit that the petitioner is innocent and a false case has been foisted against him. He would further submit that the petitioner is in custody from 01.05.2024, hence he seeks bail.

4. The learned Additional Public Prosecutor appearing for the respondent Police would submit that the petitioner has illegally prepared 9 ½ litre Toddy from Date Palm Tree. Hence he objected to grant bail to the petitioner. Further, he is having three previous cases, which are similar in nature.

5. Taking into consideration of the facts and submissions made by the learned counsels and also considering the period of incarceration, this court is inclined to
