ORDER

2.When the matter was taken up for hearing, the learned Government Advocate [Crl. Side] submits that the respondents are not harassing the petitioner. Based on the complaint given by the private respondent, the respondent Police have conducted an enquiry as against the petitioner and now the same is closed.

3.Learned Counsel for the petitioner submits that already enquiry was conducted and the petitioner attended the enquiry. After the enquiry, the complaint has been closed. In spite of that, the respondent police are calling the petitioner for enquiry and hence, the petitioner has preferred the present petition before this Court.
