2. The learned Government Advocate (Crl.side) submitted that the case is registered only under Section 174 Cr.P.C and till now the same has not been altered.

3. The learned counsel appearing for the petitioner submitted that it has been altered into IPC offences.

4. The police official is present before this Court for instruction, who has confirmed that it has not been altered and it is only under Section 174 Cr.P.C and therefore, anticipatory bail petition is not maintainable.

5. In view of the above, this petition is closed. As and when alteration is made, the petitioner is at liberty to move appropriate petition.
