PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

For anticipatory bail in the event of their arrest or surrender in connection with crime no. 60 of 2024 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioner, apprehending arrest at the hands of the respondent Police, in connection with a case in Crime No.60 of 2024, for the offence punishable under Sections 294(b), 323, 324 and 506(ii) IPC, has filed this petition seeking anticipatory bail.

2.The case of the prosecution is that due to previous enmity, on 20.05.2024, the accused have started to quarrel with the defacto complainant, abused him using filthy language and assaulted him. Hence the case.

3.The learned counsel appearing for the petitioner submits that the petitioner is an innocent person and he has not committed any offence as alleged by the prosecution. Hence, he prays for grant of anticipatory bail to the petitioner.

4.The learned Government Advocate (Crl.Side) appearing for the respondent Police submits that six stitches were put on the head of the injured and the petitioner is having two previous cases to his credit.
