2.The learned Counsel for the petitioners submitted that the petitioners are daily wage worker and they could not travel around 360 kms daily to comply with the condition imposed on the petitioners.

3.In view of the submissions made by the learned counsel for the petitioners, the condition imposed on the petitioners is modified to the effect that the petitioners
