ORDER

This Writ Petition has been filed for a Mandamus to direct the respondents to appoint the petitioner to the post of Extension Officer, Grade – II in the fourth respondent Society based on the petitioner's representation dated 02.07.2021, within a time frame to be fixed by this Court.

2.It is brought to the notice of this Court by the learned Standing Counsel appearing for the respondents that pursuant to G.O.(2D)No.20 [Animal Husbandry, Dairying and Fishery Department] dated 22.08.2019, the recruitment to the post sought

for by the petitioner is presently carried out by the Tamil Nadu Public Service Commission. Therefore, the relief sought for by the petitioner cannot be granted by the respondent and the representation given by the petitioner cannot also be considered.
