PRAYER: Writ Petition filed under Article 226 of the Constitution of India for issuance of Writ of Mandamus, forbearing the third respondent from publishing the results of the direct recruitment for the vacancies for the post of Forester (included in the Tamil Nadu Forest Subordinate Service) in the Forest Department notified vide Advertisement No.1/2018, Notification No.1-Forester, dated 06.10.2018 till the second respondent prepare and publish the promotion list of the Forest Guards fit for promotion to the post of Forester by duly following the rota-quota rule as enshrined in Rule No/12 (2) (A) governing the appointment of Forester and direct the second respondent to prepare and publish promotion list of the Forest Guards to the post of Forester from 2016 to 2018 within a time frame that may be fixed by this Court.
