ORDER

This Writ Petition has been filed for issuance of a Writ of Mandamus, seeking to direct the respondents 3 and 4 to approve the appointment of petitioner as Physical Educational Director in the 5th respondent school from the date of appointment I.e., 06.06.2019 and confer all the consequential benefits.

2.The brief facts which are necessary for the disposal of this Writ Petition is as follows:-

The petitioner was appointed in the fifth respondent minority educational higher secondary School in an unsanctioned post of Physical Educational Director, which is a needy post. Thereafter, the fifth respondent School has sent a proposal dated 20.06.2019 to the second respondent seeking approval of appointment of the petitioner in the fifth respondent. Since the same is not considered,
