2. Heard Mr.T.Indrachithu, learned counsel for the petitioner and Mr.M.Lingadurai, learned Special Government Pleader appearing for the respondents.

3. By consent of both parties, this Writ Petition is taken up for final disposal at the stage of admission itself.

4.The petitioner, who was recommended to be promoted to the post of Driver by the second respondent, has filed this writ petition seeking a direction against the first respondent to act upon the recommendation of the second respondent for promoting him to the said post.

5. In the proceedings of the second respondent, dated 06.02.2023, it is seen that the petitioner was found to be senior most among the eligible persons who can be promoted to the post of

Driver and has recommended the petitioner for the said post. So far, no order has been passed from the end of the first respondent.
