3. The learned counsel for the petitioner submits that he is having some threat at Pattukkottai and seeks for modification of the earlier condition.

4. The learned Government Advocate (Crl.Side) appearing for the respondent has also fairly confirmed that the petitioner is having life threat in Pattukkottai District.

5. Considering the submissions made, this Petition is allowed and the condition is modified to the effect the petitioner is directed to appear before the Inspector of Police, V5 - Tirumangalam Police Station, Chennai, daily at 10.30 am., until further orders.
