WEB COPY The petitioner, with a grievance that the respondents Police have not completed the investigation, has approached this Court seeking a direction to the respondents 1 and 2 to complete the investigation in Crime No.73 of 2023 and to file final report within a stipulated time.

2. The learned Additional Public Prosecutor appearing for the respondents Police submits that investigation has already been completed, however, the final report is yet to be filed. He further submits that the final report would be filed within a period of one week.

3. At this juncture, the learned counsel appearing for the petitioner/defacto complainant has raised serious objection stating that the respondent Police has conducted the investigation in a biased manner.
