The learned counsel appearing for the petitioner submits that this Court, by order dated 19.03.2024 in Crl.O.P.(MD)No.4321 of 2024, granted bail to the petitioner, with a condition that he shall appear before the respondent Police daily at 10.30 a.m. till the filing of the charge sheet. In view of the said submission, this modification is allowed and the condition imposed on the petitioner in Crl.O.P(MD) No.4321 of 2024 is modified to the effect that the petitioner is directed to report before the respondent police once in a week in every Monday at 10.30 a.m. till the filing of the charge sheet.
