This Miscellaneous Petition has been filed to modify the condition imposed in the order dated 19.03.2024 made in Crl.M.P.No.1462 of 2024 on the file of this Court in respect of first condition alone.

2.The learned counsel for the petitioner would submit that the petitioner is a very poor man and hence, the condition imposed by this Court to execute a bond for a sum of Rs.25,000/- with two blood sureties is an onerous condition. Accordingly, he prayed to modify the said condition.

3.Considering the said submission, the condition imposed as against the

petitioner is modified to the effect that the petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with one surety for a like sum to the satisfaction of the learned Additional and Sessions Judge, Mahalir Neethi Mandram (FTC), Theni.
