PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

For Anticipatory Bail in Crime No.4/2024 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioners, who apprehend arrest at the hands of the respondent police for the alleged offence punishable under Sections 294(b), 353, 506(1) IPC in Cr.No.4 of 2024 on the file of the respondent police, seek anticipatory bail.

2.The case of the prosecution is that the defacto complainant is the Inspector of Police, District Crime Branch, Madurai. The defacto complainant and his team went to arrest one Rajeshwari in connection with Cr.No.7 of 2023. At that time, the petitioners herein prevented the arrest of the above said Rajeshwari, abused them and also assaulted the defacto complainant. Hence, the case.

3.The learned counsel appearing for the petitioners submits that the petitioners are innocents persons and they did not commit any offence as alleged by the prosecution.

4.The learned Government Advocate(Crl.side) appearing for the respondent Police submits that already this Court granted anticipatory bail to the petitioners vide

order made in CrI.O.P.(MD)No.470 of 2024 dated 11.01.2024. However, the petitioners failed to execute sureties in time and thereafter, they filed a petition for extension of time and the same was also dismissed and therefore, the petitioners have filed the present petition.

5.Considering the facts and circumstances of the case and the petitioners were already granted anticipatory bail, this Court is inclined to grant anticipatory bail to the petitioners.

6.Accordingly, this criminal original petition is allowed and the petitioners are ordered to be released on bail in the event of arrest or on their appearance, within a period of fifteen days from the date of receipt of a copy of this order, before the learned Judicial Magistrate, Thirumangalam, Madurai District on condition that the petitioners shall execute a bond for a sum of Rs.25,000/-(Rupees Twenty Five Thousand) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate, Thirumangalam, Madurai District and on further conditions that:

- i. The petitioners and the sureties shall submit a copy of their Aadhaar Card or any other identity card issued by the Government in proof of their residence address;

- ii. The petitioners shall appear before the Inspector of Police, District Crime Branch, Madurai daily at 10.30 am., until further orders;
- iii. The petitioners shall not misuse the liberty granted to them by indulging in any further offence and shall not tamper with the prosecution witnesses. The petitioners shall be available for the trial as well.
- iv. On violation of any of the above conditions by the petitioners, the respondent police shall move an application for cancellation of the anticipatory bail.
