Thereafter, the petitioner has filed a private complaint before the learned Judicial Magistrate No.I, Madurai in Cr.M.P.No.4403 of 2023 and the same is pending.

3.It appears that the petitioner only filed the private complaint before the learned Judicial Magistrate No.I, Madurai and hence, he has to prosecute his complaint by producing witnesses. If the petitioner has not
