The petitioner, apprehending arrest at the hands of the respondent Police, in connection with a case in Crime No.56 of 2024, for the offence punishable under Sections 294(b), 323, 324, 336 and 506(ii) IPC, has filed this petition seeking anticipatory bail.

When the matter is taken up for hearing, the learned Government Advocate (Crl.Side) appearing for the respondent Police submits that already the petitioner has filed a petition before the learned Principal District and Sessions Judge, Pudukkottai, seeking anticipatory bail and the same is also allowed.
