2. Today, when the matter is taken up for hearing, Mr.RMS.Sethuraman, learned Additional Public Prosecutor, who takes notice

for the respondents, on instructions, submitted that the detenu is a habitual offender and there are several cases pending against him. He would further submit that the detenu has been arrested in Crime No.285 of 2024, on the file of Keeraithurai Police Station, and he is in judicial custody and the arrest intimation has also been sent to his wife. To that effect, learned Additional Public Prosecutor has also produced a copy of the first information report and arrest intimation before this Court.

3. Recording the same, the habeas corpus petition is closed.
