3. The learned Additional Public Prosecutor submits that the said Indrani has given all her properties in favour of one Vishnudevi, who is the daughter of the petitioner and she also executed a Will in favour of the said Vishnudevi. A registered

4. As per the Will dated 15.11.2022, the said Indrani has given all her properties including movable and immovable properties to the said Vishnudevi, daughter of the petitioner.
