For Anticipatory Bail in Crime No.253 of 2024 on the file of the respondent Police.

ORDER : The Court made the following order :-

The petitioner, apprehending arrest at the hands of the respondent Police, in

connection with a case in Crime No.253 of 2024 for the offence under Section 341, 294

(b), 324 and 506(ii) of IPC, has filed this petition seeking anticipatory bail.

2.The learned counsel appearing for the petitioner submits that the petitioner is an innocent person and he has not committed any offence as alleged by the prosecution. Hence, he prays for grant of anticipatory bail to the petitioner.

3.The learned Government Advocate (Crl. side) appearing for the respondent Police raised serious objection that the victim had suffered serious injury and fracture in his leg. Also, he submitted that the injured person is still taking treatment in the hospital.

4.Considering the facts and circumstances of the case, and also considering the nature of injury and the hospitalization of the victim, this Court is not inclined to grant any relief to the petitioner. Accordingly, this Criminal Original Petition is dismissed.
