ORDER

This petition has been filed seeking for a direction to the respondent police to provide police protection to the petitioner.

2. When the matter came up for hearing, the learned Additional Public Prosecutor submitted that the complaint given by the petitioner was enquired in C.S.R.No.59 of 2022 and it was closed on 10.02.2024.

3. It is seen from records that even on an earlier occasion, the petitioner had given a representation seeking for police protection and filed Crl.O.P. (MD) No.19612 of 2022. This petition was closed on
