Challenge in this writ appeal is to the order dated 05.08.2022, passed in W.P.(MD) No.7141 of 2022, by the Writ Court.

Learned Special Government Pleader appearing for the appellants fairly stated before this Court that a Similar Writ Appeal came up for consideration before this Court in ***W.A.(MD) No.310 of 2023, dated 27.03.2023 (in the matter of the Commissioner of Land Administration v.
