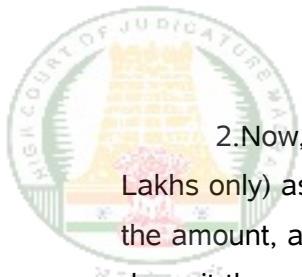

This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant/s Mr.M.Jerin Mathew, Advocate and the counsel for the respondents Mr.A.Theethar, Advocate are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

## **AWARD**

This Civil Miscellaneous Appeal is filed as against the Judgment passed in MCOP No.562 of 2017, dated 20.01.2023 passed by the Motor Accidents Claim Tribunal / IV Additional Sub Judge, Madurai, directing the Insurance Company to deposit a sum of Rs.26,59,280/- with 7.5% interest to the credit of Motor Accidents Claim Tribunal / IV Additional Sub Judge, Madurai.



2. Now, both the parties have arrived at a settlement of Rs.27,00,000/- (Rupees Twenty Seven Lakhs only) as full quit and the same is recorded. The claimant is at liberty to withdraw the amount, less the amount, already withdrawn by the claimant, if any. The appellant Insurance Company is directed to deposit the said amount within a period of four weeks from today, less the amount already deposited, if any.
