2. At the time of admission, a direction was issued by this Court to keep one post vacant in Kumbam Block under spouse category.

Learned Additional Advocate General, appearing for the respondents, pointed out that without prejudice to his contentions with regard to the merits of the writ petition, the petitioner could be accommodated at Myladumparai Block in Theni District in case the petitioner submits an application by accepting the said vacancy.

4. In view of the above said facts, the writ petitioner is hereby directed to submit an application to the respondents by accepting the said vacancy and, on receipt of the said application, the respondent authorities are directed to post the petitioner in the said vacancy.

5. With the above said observation, this Writ Petition stands disposed of. No costs. Consequently, the connected W.M.P.(MD) No.11573 of 2024 is closed.
