I therefore direct the District Revenue Officer, Tuticorin to dispose of the petitioner's revision petition dated 20.11.2023 filed against the proceedings bearing No.Moo.mu.A2/7228/2021, dated 18.08.2023 passed by the Sub Collector, Kovilpatti. After due notice to all the interested persons, final order shall be passed by the District Revenue Officer, Tuticorin within a period of eight weeks from the date of receipt of a copy of this order. This writ petition stands disposed of accordingly. No costs. Consequently, connected miscellaneous petition is closed.
