Taking into consideration the facts and circumstances of the case, the condition imposed by this Court in Crl.O.P(MD) No.7580 of 2024 dated 29.05.2024 in para 6(b) is modified to the effect that the petitioner shall appear before the learned Judicial Magistrate, Nanguneri, daily at 10.30 a.m., for a period of four weeks and thereafter, as and when required for interrogation.

5. With the above direction this petition is allowed.
