Prayer in Crl.M.P.(MD)No.15246 of 2023:-

Criminal Miscellaneous Petition filed under section 482 of Cr.P.C. To grant extension of time granted in the order made in Crl.O.P.(MD)No.16378 of 2023, dated 14.09.2023 on the file of this Honourable Court and to pass such further or other orders as this Hon'ble Court.

Prayer in Crl.O.P.(MD)No.16378 of 2023:-

Criminal Original Petition filed under Section 482 of Cr.P.C. To direct the Principal District and Sessions Judge, Karur to consider the bail application of the Petitioner on the same day of their surrender before that Court in connection with Crime No.396 of 2023 on the file of the Respondent.

2.The learned Government Advocate(Crl.side) appearing for the respondent

submits that this is the second petition for extension of time and originally a direction was given on 14.09.2023 to the petitioner to surrender before the Court below.
