2.The case of the prosecution is that the petitioner along with other accused illegally transported ½ unit of Odai sand in a tractor bearing Reg. No. TN 49 BR 0511. Hence, the complaint.

3.The learned counsel for the petitioner submits that the petitioner is an innocent and he did not commit any offence as alleged by the prosecution.

4.The learned Government Advocate (Crl.side) appearing for the respondent submits that totally thirteen previous cases are pending as against this petitioner, out of which, six cases are of similar in nature.

5.Considering the nature of offence and the antecedents of the petitioner, this Court is not inclined to grant anticipatory bail to the petitioner. Accordingly, this Criminal Original Petition is dismissed.
