The learned counsel for the petitioner / defacto complainant submits that the 2nd respondent herein / A4 has already filed an application for anticipatory bail before the learned Principal District Judge, Tiruchirappalli on 20.05.2024 in V.C.Crl.M.P.No.279 of 2024.
