In view of the order passed by the Hon'ble Supreme Court in **S.L.P.No.15702 of 2021, dated 16.02.2024** in the matter of **Secretary to Government, Government of Tamil Nadu and others vs. Iruthaya Amali and another**, the petitioner cannot straightaway file a contempt petition as if that, the order passed by the Division Bench of this Court made in WP(MD)No.10063 of 20202 dated 31.03.2021, has been violated specifically insofar as the appointment of the present petitioner is concerned.
