PETITION FOR BAIL Under Sec.439 of Cr.P.C.

PRAYER :-

To enlarge the Petitioner/ Accused on bail in PRC No.334/2024 before the Learned Judicial Magistrate No.V, Tirunelveli, Tirunelveli District, Crime no.353/2023 on the file of the Respondent police.

ORDER: The Court made the following order :-

The petitioners/Accused, are facing trial for the offences punishable under Sections 341, 302, 506(ii), 294(b) and 120(B) IPC in P.R.C.No.334 of 2024, on the file of the learned Judicial Magistrate No.V, Tirunelveli District in Crime No.353 of 2023, on the file of the respondent police. Therefore, the petitioners have filed this petition seeking bail.

2. The case of the prosecution is that due to previous enmity, on 16.09.2023, the petitioners along with the other accused have attacked the husband of the defacto complainant and murdered him. Hence the case.

3. The learned counsel for the petitioners submits that the petitioners are innocent persons and they have not committed any offence as alleged by the prosecution. However, they are languishing in jail from 16.03.2023. Hence, he prays for grant of bail to the petitioners.

4. The learned Additional Public Prosecutor appearing for the respondent submits that the petitioners' father was murdered by the deceased and the deceased

had created problem with the petitioners, two days prior to the occurrence.

Therefore, the petitioners have committed the murder. Now, the case is committed before the learned Additional Judge No.III, Tirunelveli, in S.C.No.20 of 2024. He further submits that no previous case is pending against the petitioners.

5. Considering the facts and circumstances of the case, the period of incarceration and also considering the fact that the petitioners are not having any previous case, this Court is inclined to grant bail to the petitioners.

6. Accordingly, this Criminal Original Petition is ordered and the petitioners are ordered to be released on bail

i) on the petitioners executing a bond for a sum of Rs.25,000/- (Rupees Twenty Five Thousand) each, with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.V, Tirunelveli District.

ii) The petitioners and the sureties shall submit a copy of their Aadhaar Card or any other identity card issued by the Government in proof of their residence address;

iii) The petitioners shall stay at Villupuram District and report before the Villupuram Town police Station daily at 10.30 a.m. until further orders. They have to co-operate for the investigation.

iv) The petitioners shall not misuse the liberty granted to them by indulging in any further offence and shall not tamper with the prosecution witnesses. They shall be available for the trial as well.

v) On violation of any of the above conditions by the petitioners, the respondent police shall move an application for cancellation of the bail.
